**OF THE CLARK COUNTY-SPRINGFIELD TRANSPORTATION
COORDINATING COMMITTEE TO APPROVE AMENDMENT # 1 FOR THE
FY2019 PLANNING WORK PROGRAM**

WHEREAS, the Clark County-Springfield Transportation Coordinating Committee (CCSTCC) is designated the Metropolitan Planning Organization (MPO) for the Springfield urbanized area in Clark County by the Governor of the State of Ohio, acting through the Ohio Department of Transportation (ODOT), and in cooperation with locally elected officials in the area pursuant to Agreement of Cooperation #30100 between ODOT and the Board of Commissioners of Clark County, Ohio; and

WHEREAS, CCSTCC is responsible for producing and implementing an annual Planning Work Program (PWP), in cooperation with ODOT to describe the budget and work that will be performed by the CCSTCC staff for the respective year; and

WHEREAS, \$ 103,940.45 of TCC FY2018 Consolidated Planning Grant (CPG) will be carried forward and spent before December 31, 2018 per ODOT prior approval; and

WHEREAS, \$ 44,827.00 of LUC FY2018 Statewide Planning & Research Grant (SPR) will be carried forward and spent before December 31, 2018 per ODOT prior approval; and

WHEREAS, \$ 3,092.05 will be reduced from the proposed FY2019 budget in Direct Labor, Fringe Benefits and Indirect Costs for Transportation Improvement Program (602.11); and

WHEREAS, \$ 26,163.50 of Direct Labor, Fringe Benefits and Indirect Costs from work element 610.11 Long Range Planning will be moved to Direct Labor, Fringe Benefits and Indirect costs within work element 605.11 Surveillance; and


WHEREAS, \$ 11,528.00 will be added to the proposed FY2019 budget in Consultant Expenses for RTPO Planning (625.11); and

WHEREAS, \$ 7,135.50 within work element 625.11 RTPO Planning will be moved from Direct Labor, Fringe Benefits and Indirect Costs to Consultant Expenses; and

WHEREAS, these budget amendments result in an overall increase of \$ 8,435.95 to the FY2019 PWP and a new Grand Total budget of \$ 1,084,334.47.

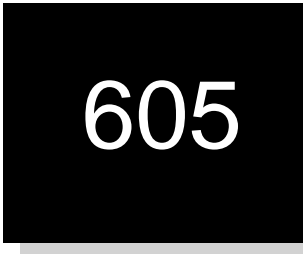
BE IT THEREFORE RESOLVED:
