**WHEREAS**, the Clark County-Springfield Transportation Coordinating Committee (TCC) is designated the Metropolitan Planning Organization for area-wide transportation planning in Clark County by the Governor of the State of Ohio in accordance with the regulations of the United States Department of Transportation; and

**WHEREAS**, the TCC is responsible for maintaining the area's Transportation Improvement Program (TIP), in cooperation with local governments, transportation providers and the Ohio Department of Transportation; and

**WHEREAS**, the TIP is prepared in cooperation with local governments, operators and publicly –owned transit and rail freight systems, the Ohio Department of Transportation and the U.S. Department of Transportation; and

**WHEREAS**, the City of Springfield desires to make the following fiscally constrained purchases and/or improvements: Purchase of five (5) light transit vehicles for replacement of fixed-route buses, SCAT facility improvements, vehicle preventive maintenance. Aforementioned fiscally constrained purchases and/or improvements shall not exceed \$1,148,714. Funding shall be obtained through the American Recovery and Reinvestment Act and;

**WHEREAS**, the City of Springfield desires to make the following non-fiscally constrained purchases and/or improvements : Purchase of an additional three (3) light transit vehicles for replacement of fixed-route buses, additional vehicle preventive maintenance, addition of electronic ticket vending machines and miscellaneous improvements for Market Square Bus Center. Aforementioned non-fiscally constrained purchases and/or improvements shall not exceed \$1,148,714. Funding shall be obtained through the American Recovery and Reinvestment Act in the event that funding beyond the fiscal year annual cap is available and;

**WHEREAS**, the next Transportation Improvement Program update will not occur until FY2012.

**BE IT THEREFORE RESOLVED:**

That the members of the Clark County-Springfield Transportation Coordinating Committee approve the amendment to the FY2008 – 2011 Transportation Improvement Program as shown on the reverse side of this resolution.
