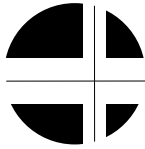

RE: 60 MPH Speed Limit on US40 in South Vienna

Dear Mr. Chevalley,

On behalf of the Clark County-Springfield Transportation Coordinating Committee (CCSTCC), I am writing to you today to oppose the increase in the speed limit on US40 in the Village of South Vienna in Clark County. This section is part of nearly 9 miles of US40 in eastern Clark County that is now posted at 60 miles per hour, which took effect as a result of new legislation passed by the Ohio General Assembly earlier this year.

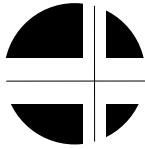
While the majority of this section is in an unincorporated area, the CCSTCC is requesting that ODOT return to a posted 50 mph speed limit within the Village due to concerns with vehicular safety. There have been two fatal crashes on this stretch of US40 within the past three years and there are local schools located just northwest of the US40 and SR54 intersection.

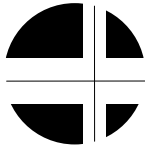
