Staff is requesting the following prior approval for expenses:

- An amount not to exceed \$1,000 for 2 TCC staff members to attend the Ohio Conference on Freight 2014 in Columbus September 18-19, 2014. The estimate includes registration, mileage, and parking.

OF THE CLARK COUNTY-SPRINGFIELD TRANSPORTATION COORDINATING
COMMITTEE TO ACCEPT THE SFY 2014 PLANNING WORK PROGRAM COMPLETION
REPORT

WHEREAS, the Clark County-Springfield Transportation Coordinating Committee (CCSTCC) is designated the Metropolitan Planning Organization (MPO) for the Springfield urbanized area in Clark County by the Governor of the State of Ohio, acting through the Ohio Department of Transportation (ODOT), and in cooperation with locally elected officials in the area pursuant to Agreement of Cooperation #17665 between ODOT and the Board of Commissioners of Clark County, Ohio; and

WHEREAS, CCSTCC has the authority and responsibility for the direction, coordination, and administration of the area-wide transportation planning process in accordance with 23 USC 134 and 49 USC 5303 and as described in the CCSTCC Prospectus dated November 2011; and

WHEREAS, the Planning Work Program establishes the methodologies and budget to implement the area-wide transportation planning process and program activities for the upcoming fiscal year; and

WHEREAS, the SFY 2014 Planning Work Program Completion Report includes a narrative description and financial expenditure summary for each work element in the ODOT approved SFY 2014 Planning Work Program and budget; and

WHEREAS, CCSTCC has reviewed the Completion Report and finds it consistent with the work and budget of the approved SFY 2014 Planning Work Program.

BE IT THEREFORE RESOLVED:

That the members of the Clark County –Springfield Transportation Coordinating Committee hereby accept the SFY 2014 Planning Work Program Completion Report.
